Applicable Instruments and Degree of Authorization

This is Appendix 1 to the Agreement dated 16/05/2016 between Government of the Republic of Sri Lanka (the Administration) and DNV GL AS together called "the Parties".

The Parties have agreed on the following:

 DNV GL AS is hereby authorized as listed below to carry out statutory certification services on behalf of the Administration with respect to ships and mobile offshore units, and registered in the Republic of Sri Lanka in accordance with the applicable instruments as mentioned below.

The following three types of authorizations apply as noted:

- F: Full authorization to perform review of plans, documents and manuals, approve and inspect materials and equipment and carry out surveys, audits and inspections and issue and/or revoke necessary interim and full-term certificates.
- P: Partial authorization to perform review of plans, documents and manuals, carry out surveys, audits and inspections and possible issue of interim certificates. (Specific guidance is to be provided by the Administration and full-term certificate is to be issued by the Administration).
- L: Limited authorization to account for other special categories not covered by the above, such as case-by-case authorization or geographical limitations.

Where certain instruments have not come into effect for the Administration, DNV GL AS shall designate the Certificates as 'Document of Compliance'.
