Joint Maritime Commission

Composition

- 1. Further to the decision adopted by the Governing Body at its 294th Session (November 2005), the 30th Session of the Joint Maritime Commission was held on 23 February 2006 just after the closing of the 94th (Maritime) Session of the International Labour Conference. In accordance with article 1 of the Standing Orders of the Joint Maritime Commission, two members were appointed by the Governing Body in November 2005 ¹ to represent respectively the Employers' group and the Workers' group of the Governing Body and 40 members were nominated by the International Labour Conference at its Maritime Session in February 2006. Among these 40 members, 20 were selected by the Shipowners' delegates and 20 by the Seafarers' delegates to the Conference. Eight deputy members (four Shipowners and four Seafarers) were also nominated by the Conference.
