### Building the capacity of OSH systems


In the framework of the ILO Programme, “Improving Working Conditions in the Ready Made Garment (RMG)”, the component “Building the capacity of OSH systems” aims at reinforcing the capacity of workers, supervisors and managers in the RMG sector to improve the safety of their workplaces. In this respect, in the consultations held in April 2014

with BEF, BGMEA and BKMEA, employers’ representatives highlighted their need - To boost a safety culture at workplace and implement practical measure to reduce risks of accidents via a layered training of

- 100 Master trainers
- 7.500 Middle level managers and chiefs in floors
- 500.000 workers as final beneficiaries

## State of Implementation


Phase 1 of the project was successfully completed:

- More than 100 trainers accurately selected by BEF, BGMAE and BKMAE were trained on how to use the ITC ILO package “Essentials of Occupational Safety and Health – EOSH” to deliver training sessions in factories for middle level managers and chief in floors.
- New training material in Bangla was produced to integrate the EOSH material.



As from March 2015 delivery in RMG sector factories will start.

Workshops will be organized in hundreds of RMG factories to reach out to 7.500 middle level managers. Factories might choose most needed topics amongst the key eight ones identified in the preliminary consultations depending on local needs.
