## 16:00-18:00 Session II: Low Carbon Economies and the Labour Market: Renewables and Energy Efficiency

In particular, the session will address the following questions: Low-carbon economies, or more generally economies low in the emission of greenhouse gases, are essential if the world is to avoid dangerous climate change. The IPCC reports call for emissions to peak within the next 10 years and then to be reduced to less than half their levels in 1990. This session will explore the employment potential linked to the rapid development of renewable energy like solar, wind and biomass, as well as of 'negawatts' i.e. reductions in energy consumption through improvements in energy efficiency, particularly in buildings and in industry. The session will consider experiences with tapping the major potential for synergies between the goals and investments for emissions reductions, employment generation and development opportunities for hitherto marginalized groups and regions.

In spite of efforts to 'dematerialize' economic growth and to decouple it from the use of raw materials and natural resources, current economic development is putting severe pressure on resources, reflected in both escalating commodity prices, exhaustion of some natural resources and widespread pollution. Recycling will become an essential part of increasingly closed production and value-added cycles. This activity is already a significant source of employment, but often of low quality jobs rather than of decent work. The session will learn from experiences with advanced recycling schemes and identify opportunities for the creation of more and better jobs in what looks set to be a growth sector.
