### The Employment - Environment - Climate Nexus

Employment and environmental sustainability factsheet

November 2022

### Key figures

The Employment-Environment-Climate Nexus Factsheets are a series produced for countries in the Asia-Pacific region. This Factsheet provides key features of labour market and environmental sustainability performance in Cambodia, as well as vulnerability to climate change and sectors with green jobs potential. Key figures from the brief are as followed:

- ► Cambodia has a population of 17 million people, of which 30.7 per cent are below 14 years old.
- ▶ Of 9 million employed in the country, approximately 34.5 per cent work in agriculture, 27.9 per cent in industry and 37.6 per cent in services.
- ▶ Cambodia ranks 154th of 180 countries in the latest Environmental Performance Index (EPI), 2022. The EPI assesses countries on 40 different performance indicators and ranks them according to their national efforts towards environmental health, to enhance ecosystem vitality and mitigate climate change.
- ▶ The level of PM2.5 (atmospheric particulate matter with a diameter of less than 2.5 micrometres) emissions for Cambodia is estimated at 25.6 (micrograms per cubic metre) in 2017, compared to an unweighted average of 27.6 in Asia-Pacific.
- ► Around 31.8 per cent of total territorial area in the country were territorial or marine protected areas.

- ► Cambodia ranks 20th of 35 countries in the Asia-Pacific region in the Notre Dame Global Adaptation Index, in terms of vulnerability components. This index considers vulnerability to climate change and related global challenges as well as resiliency and preparedness.
- ▶ Cambodia remains highly vulnerable to the impacts of climate change due to its high dependency on climate-sensitive sectors such as agriculture, water resources, forestry, fisheries, tourism, and other sectors. Projected climate change trends point to more severe floods and droughts, which is expected to affect Cambodia's GDP by nearly 10 per cent by 2050.
- ▶ Renewable energy as a share of total energy consumption was estimated at around 53.4 per cent in 2018. Renewable energy sources produced 4,255 GWh in 2020, following annual average growth of 26.3 per cent since 2000.
- ▶ Renewable hydropower accounted for the highest share of total renewable energy generation in 2020, accounting for 90.7 per cent of total renewable energy generation in the country.
- ► Around 17,021 people in Cambodia were employed in the renewable energy sector in 2020. Hydropower accounted for the highest share, at 100.0 per cent.

### ▶ Country overview

Cambodia is a country of around 181,035 km² located in South-Eastern Asia (Figure 1).² With Gross National Income (GNI) of US\$ 1,550 per capita in 2021, Cambodia is categorized as lower-middle income according to the World Bank income group classification.³


#### ► Figure 1. Map of Cambodia



Gross Domestic Product (GDP) was estimated to have grown 3.0 per cent in 2021.<sup>4</sup> This compares to 5.8 per annum over the last decade (2011-2021).

The population was estimated at 16,946,446 in 2021, representing annual average population growth of 1.5 per cent per annum over the last decade. This is underpinned by a fertility rate of 2.5 births per woman in 2020 and life expectancy of 70.1 years in 2020 (from 67.0 a decade earlier). In 2021, a total of 24.7 per cent lived in urban areas.

# ► Figure 2. Composition of total population by age-group, 2021 (percentage)





### Labour market

The total labour force (aged 15+) was estimated at 9,358,081 in 2021, corresponding to a labour force participation rate of 79.7 per cent.<sup>8</sup> Around 48.4 per cent of the total labour force were women. Women had a labour force participation rate of 74.0 per cent, compared to 85.9 per cent for men.

Total employment (aged 15+) was estimated at 9,300,886 in 2021, representing an employment-to-population ratio of 79.2 per cent.<sup>9</sup> By broad sector group, agriculture accounted for 34.5 per cent of total employment, industry a further 27.9 per cent and services, 37.6 per cent in 2019 (Figure 3).

## ► Figure 3. Composition of total employment by broad sector group, 2019 (thousands)





There were an estimated 57,271 unemployed persons in the country in 2021, corresponding to a total unemployment rate of 0.6 per cent. <sup>10</sup> The unemployment rate for women was estimated at 0.7 per cent, compared to men at 0.5 per cent. Youth were estimated to exhibit an unemployment rate of around 1.8 per cent.

Having a job does not, however, guarantee quality employment. A total of 53.0 per cent of the total employed population were in wage and salaried employment in 2019. <sup>11</sup> Wage and salaried employment is associated with more higher degrees of job security, more regular incomes as well as greater access and eligibility to social protection as well as coverage by employment regulation, than those in self-employment. Accordingly, the remaining 47.0 per cent of total employment, who are classified as being self-

employed, encompass employers, own-account workers and contributing family workers (Figure 4).12


### Environment and vulnerability to climate change

Cambodia ranks 154th of 180 countries in the latest Environmental Performance Index (EPI), 2022.13 The EPI assesses countries on 40 different performance indicators and ranks them according to their national efforts towards environmental health, to enhance ecosystem vitality and mitigate climate change.

According to the assessment criteria, Cambodia scores 30.1 points on a scale of 0-100 (where 0 is worst and 100 best performing). For reference, in 2022, the highestranking countries were in Europe, including Denmark and the United Kingdom, with respective scores of 77.9 and 77.7. In Asia and the Pacific, the scores range from highest ranking in Australia (60.1) to lowest ranking in India (18.9).

Figure 5 shows a selection of indicators for Cambodia and how it compares to the highest and lowest scores for countries in the Asia-Pacific with available data, thereby allowing a gauge of where the country performs better or worse in relative terms.

#### ▶ Figure 5. Environmental performance index and selected indicators, Cambodia and Asia-Pacific, 2022





Action to improve environmental health, ecosystem vitality, climate change and resilience to weather disasters all have the potential to provide job creation, green economy growth and innovation in the country.

As shown in Figure 6, around 68.8 per cent of the population had access to at least basic sanitation services in 2020.14 This represents a change from 9.8 in 2000. Around 71.2 per cent of the population were using at least basic drinking water services (from 52.6 per cent in 2000); 86.4 per cent had access to electricity (from 16.6 per cent in 2000); and 36.8 per cent had access to clean fuels and technologies for cooking (from 3.6 per cent in 2000). 15


Around 39.7 per cent of Cambodia's land area is forest area, down from around 70 per cent in 1990. Forest area in this context refers to land under natural or planted stands of trees of at least 5 meters in situ, whether productive or not, and excludes tree stands in agricultural production systems (for example, in fruit plantations and agroforestry systems) and trees in urban parks and gardens. Notably, Cambodia has a target of 60 per cent forest cover. Of the total land area, around 31.8 per cent is agricultural land (compared to 27.7 per cent in 2001). Agricultural land in this context refers to the share of land area that is arable, under permanent crops, and under permanent pastures.

Protected areas are a crucial means of environmental preservation and conservation. In Cambodia, around 39.7 per cent of total land area were protected areas in 2021 (Figure 7), compared to 26.0 per cent in 2016. 19 Terrestrial protected areas in this context are totally or partially protected areas of at least 1,000 hectares that are designated by national authorities as scientific reserves with limited public access, national parks, natural

monuments, nature reserves or wildlife sanctuaries, protected landscapes, and areas managed mainly for sustainable use.

Once marine protected areas are incorporated, around 31.8 per cent of total territorial area were territorial or marine protected areas. <sup>20</sup> Marine protected areas in this context refer to areas of intertidal or subtidal terrain--and overlying water and associated flora and fauna and historical and cultural features--that have been reserved by law or other effective means to protect part or all of the enclosed environment.



There will be greater prospects for employment opportunities if there is commitment to transition to a low carbon and resource-efficient economy, such as jobs in resource management and environmental services.


## ► Figure 8. CO2 emissions, 2000-2019, Cambodia, ASEAN and Asia-Pacific (metric tonnes per capita)

The carbon dioxide (CO2) emission levels for Cambodia are estimated at around 16,180 kt in 2019.<sup>21</sup> This marks a change from 1,960 kt in 2000, representing annual average growth in CO2 emissions of 11.8 per cent from 2000-2019. While total CO2 emissions are largely related to the size of the economy, a per-capita metric serves as a relative measure for comparing countries (Figure 8). In 2019, the unweighted average across Asia-Pacific countries was estimated at 4.4 metric tonnes per capita. In Cambodia it

was estimated at 1.0 metric tonnes per capita for the same year.

The level of PM2.5 (atmospheric particulate matter with a diameter of less than 2.5 micrometres) emissions for Cambodia is estimated at 25.6 (micrograms per cubic metre) in 2017, compared to 30.0 in 2000 (Figure 9).<sup>22</sup> It also compares to an unweighted average across Asia-Pacific countries of 27.6 in 2017. Notably, the World Health Organization's Air Quality Guideline threshold level emission is stated at 10 micrograms per cubic metre. The percentage of the population exposed to ambient concentrations of PM2.5 that exceed the WHO guideline (the lower end of the range of concentrations over which adverse health effects due to PM2.5 exposure have been observed) is estimated at 100.0 per cent in 2017, compared to 100.0 per cent in 2000.



The Notre Dame Global Adaptation Index considers vulnerability to climate change and related global challenges as well as resiliency and preparedness. <sup>23</sup> Looking only at the vulnerability components of the index, Cambodia scores 0.51 (where 0 is very vulnerable and 1 is least vulnerable), which, for reference, ranks Cambodia 20th of 35 countries in the Asia-Pacific region with a score in the database.


► Figure 10. Notre Dame Global Adaptation Index, Vulnerability and composite indicators, 2020, Cambodia, Asia-Pacific (index score)

Figure 10 provides other comparisons of how the country fares relative to other countries in the Asia-Pacific region with respect to different composite indicators of the vulnerability component of the index. For instance, it shows that for ecosystems – i.e. that which provides the natural capital upon which human society builds its economy and social system and include natural resources that are at the foundation of all almost all product value chains – Cambodia has a score of 0.45, relative to highs (least vulnerable) in the region of 0.68 and lows of 0.33. Shifting geoclimes due to changed temperature and precipitation cause stress within ecosystems unable to respond as quickly as these shifts require.<sup>24</sup>

Over the 2016-2021 period, there were a total of 8 natural disasters in Cambodia (natural disasters in this context includes floods, droughts, epidemics, storms, landslides, earthquakes and wildfires). <sup>25</sup> This compares to 5 natural disasters over the 1992-1996 5-year period. There are substantial costs to these events, which, for the 2016-2021 period, amounted to US\$ 105 million.

# ► Figure 11. Number of natural disasters (LHS) and total cost of natural disasters (RHS – US\$ million) per 5-year period, 1992-2021



### Sectors with green jobs potential


► Figure 12. Total renewable energy generation (GWh), 2000-2020

In 2018, renewable energy as a share of total energy consumption was estimated at around 53.4 per cent. This compares to 81.6 per cent in 2000.<sup>26</sup> Renewable energy sources produced 4,255 GWh in 2020 (Figure 12).<sup>27</sup> With total renewable energy sources producing 40 GWh in 2000, it represents annual average growth of 26.3 per cent between 2000-2020.


# ► Figure 13. Renewable energy generation (GWh) by technology, 2020

Renewable hydropower accounted for the highest share of total renewable energy generation in 2020, at 3,860 GWh, equivalent to 90.7 per cent of total renewable energy generation in the country (Figure 13).<sup>28</sup>

According to estimates by the International Renewable Energy Agency (IRENA), 17,021 people in Cambodia were employed in the renewable energy sector in 2020. Hydropower accounted for the highest share (100.0 per cent) of total employment in renewable energy in the country (Figure 14).<sup>29</sup>

Better data on green and decent jobs is particularly needed to assess the impact of climate change and climate-related policies on social inclusion. Without better data, it will be difficult to determine what policy changes are needed to assure a just transition to environmental sustainability and to monitor progress going forward.
