Fourth Supplementary Report: Follow-up to Governing Body decisions

Purpose of the document

Introduction

1. In March 2011, the Governing Body decided that, as part of the reform package,¹ the Office should prepare a supplementary report of the Director-General outlining, in a tabular or matrix form, the follow-up action taken by the Office on decisions previously adopted by the Governing Body.
2. In March 2015, the Governing Body requested the Office to limit the reporting period for a given item to a maximum of two years, unless further action was required, in order to streamline the document, which had grown considerably since its conception in 2011.
3. To further improve this document, the Governing Body may wish to request the Office to exclude from future editions of this report those standing items that are either reported on annually or discussed in the Governing Body on a regular basis. This applies to items such as the agenda of the International Labour Conference (discussed at the March and November sessions), the Review of annual reports under the follow-up to the ILO Declaration on the Fundamental Principles and Rights at Work (submitted annually), and other similar items.
4. The table below displays: (1) the decisions adopted requiring follow-up action; (2) the actions already taken or envisaged by the Office to give effect to these decisions; (3) the planned date for reporting to the Governing Body; and (4) the implementation status. The shaded rows correspond to follow-up action that has been completed and which will be removed from the next report.
