## 1. Election of the Officers of the Committee

In accordance with article 57 of the Standing Orders of the Conference, the Selection Committee elected its Officers as follows:

*Chairperson:* Mr P. Mudyawabikwa (Zimbabwe)

*Employer Vice-Chairperson:* Mr H. Matsui (Japan)

*Worker Vice-Chairperson:* Mr L. Cortebeeck (Belgium)

## 2. Reminder of the Selection Committee's authority under the Standing Orders

The Selection Committee was reminded that, under article 4(2) of the Standing Orders, it was responsible, in addition to its traditional authority, for fixing the time and agenda of the plenary sittings and for acting on behalf of the Conference with respect to decisions on non-controversial questions of a routine nature. Thus, except where consensus could not be reached in respect of any particular question requiring a decision for the proper conduct of business, the Selection Committee could decide on its own authority and its decisions did not need to be endorsed by the Conference.

## 3. Discussion of the Reports of the Chairperson of the Governing Body and of the Director-General: Opening date for the discussion and closing date for the list of speakers

*The Selection Committee decided that the discussion of the Reports of the Chairperson of the Governing Body and of the Director-General would begin on Wednesday, 7 June, at 10 a.m., and that the list of speakers would be closed on the same day at 6 p.m., under the usual conditions.*

## 4. Plan of work of Conference committees

The Selection Committee endorsed a draft plan of work for committees, which although not binding for them, would enable the committees, in organizing their work, to take maximum possible account of the overall needs and possibilities of the Conference. The plan is attached in tabular form in Appendix I.

The Chairperson of the Selection Committee stressed that the Committee had a responsibility to ensure the smooth running of the Conference. This responsibility was particularly important given that the Conference was taking place once again in a shortened period of time, and its agenda included a second discussion of a standard-setting item, as well as the consideration of the draft programme and budget of the ILO for 2018–19. The Governing Body elections were also to be held during the session. For this reason, time management was particularly important. The Officers of the Selection Committee therefore wished to convey a message to the Officers and secretariats of all committees, laying great stress on the need to begin sittings punctually and to respect schedules.

## 5. Abrogation of Conventions Nos 4, 15, 28, 41, 60 and 67

Following the entry into force on 8 October 2015 of the 1997 Instrument for the Amendment of the Constitution of the International Labour Organisation, the Governing Body of the International Labour Office decided at its 325th Session (November 2015) to place on the agenda of the 106th Session (2017) of the International Labour Conference the question of abrogation of the following Conventions: the Night Work (Women) Convention, 1919 (No. 4); the Minimum Age (Trimmers and Stokers) Convention, 1921 (No. 15); the Protection against Accidents (Dockers) Convention, 1929 (No. 28); the Night Work (Women) Convention (Revised), 1934 (No. 41); the Minimum Age (Non-Industrial Employment) Convention (Revised), 1937 (No. 60); and the Hours of Work and Rest Periods (Road Transport) Convention, 1939 (No. 67).

The Conference is empowered by two-thirds majority and upon recommendation by the Governing Body, to abrogate a Convention in force if it appears that it has lost its purpose or that it no longer makes a useful contribution to attaining the objectives of the Organization. The procedure for abrogation applies to Conventions which are in force. The procedure for withdrawal applies to Conventions which have never entered into force or are no longer in force due to denunciations.

The abrogation/withdrawal of the instruments in question will put an end to their legal effect vis-à-vis the Organization and will contribute to the rationalization of the standard-setting system of the International Labour Organization.

In accordance with article 45bis(2) of the Standing Orders of the International Labour Conference, the Office communicated to the governments of all member States, more than 18 months before the opening of the present session of the Conference, a short report summing up the reasons put forward by the Governing Body for the abrogation or withdrawal of the Conventions,<sup>1</sup> and containing a questionnaire requesting member States to indicate, before 30 November 2016 at the latest, their position on the subject of the said abrogation or withdrawal. The Office then produced a second report,<sup>2</sup> summarizing and commenting on the replies received to the questionnaire and including a set of proposed conclusions, prepared on the basis of the replies for the consideration and adoption by the 106th Session of the Conference. Both reports are before the Conference under item VII on its agenda.

***The Selection Committee unanimously recommended to the Conference that it take the preliminary decision, referred to in paragraph 3 of article 45bis of the Standing Orders of the Conference, to submit the formal proposal for the abrogation or withdrawal of each of the six Conventions, as set out in Appendix III to the present report, to a final vote. The Committee further decided that, should the Conference take the proposed preliminary decision, the vote would be held on Wednesday, 14 June 2017.***

## 6. Governing Body elections

*The Selection Committee decided that the meetings of the electoral colleges should be held in the afternoon of Monday, 12 June, in the following order: Employers' electoral college, Workers' electoral college and Government electoral college.*

In accordance with the provisions of article 52(3) of the Standing Orders of the Conference, the three electoral colleges could choose to use the electronic voting system for the elections.<sup>3</sup>

## 7. Suggestions to facilitate the work of the Conference

*As in previous years, the Selection Committee confirms the following principles:*

### (a) Quorum

- (i) The quorum would be fixed provisionally, on the basis of the credentials received, in the brief report of the Chairperson of the Governing Body on the day before the opening of the Conference; the said report is published in *Provisional Record* No. 5A. This provisional quorum would remain unchanged until the quorum was determined under the authority of the Credentials Committee, on the basis of registrations.
- (ii) Thereafter, the quorum would be continuously adjusted, under the authority of the Credentials Committee, so as to take into account new registrations and notices of departure from delegates leaving the Conference.
- (iii) Delegates should register personally, immediately on arrival, as the quorum was calculated on the basis of the number of delegates registered.
- (iv) Acceptance of appointment as a delegate implied an obligation to be available in Geneva personally, or through an adviser authorized to act as a substitute for the work of the Conference until its end, as important votes often took place on the last day.
- (v) Delegates who were nevertheless obliged to leave the Conference before it finished should give notice of their forthcoming departure to the secretariat of the Conference. The form utilized to indicate their date of departure also enabled them to authorize an adviser to act and to vote in their place. At group meetings held during the second half of the Conference, the attention of members of the groups would be drawn to the importance of completing and handing in this form.
- (vi) In addition, one Government delegate of a country could report the departure of the other Government delegate, and the secretaries of the Employers' and Workers' groups could also give notice of the final departure of members of their groups, who had not authorized advisers to act in their place.
- (vii) When a record vote was taken in plenary while committees were sitting, delegates were both entitled and expected to leave committees to vote unless they were replaced by a substitute in plenary. Announcements were made in the committees to ensure that all

delegates were aware that a record vote was about to take place. Appropriate arrangements would be made for committees meeting in the ILO building.

**(b) Punctuality**

The Selection Committee would encourage committee chairpersons to start proceedings punctually, irrespective of the number of persons present, but on condition that votes will not be taken unless a quorum was clearly present. This was particularly important in view of the two-week format of this year's Conference.

**(c) Negotiations**

In order to facilitate more continuous negotiation in committees among delegates, representatives of each group should meet with the chairperson and reporter of the committee and with the representative of the Secretary-General, whenever this was desirable, to ensure that the leaders of each group knew fully the minds of the delegates in the other groups. The function of these informal meetings was to afford opportunities for a fuller understanding of differences of view before definite positions had crystallized.

**8. Participation in Conference committees by Members having lost the right to vote**

At its 239th Session (February–March 1988), the Governing Body considered the implications of the appointment, as regular members of Conference committees, of representatives of a member State which had lost the right to vote under article 13(4) of the Constitution of the ILO. It noted that, while the appointment of Employer and Worker representatives from such a State had no practical implications, because the Employers' and Workers' groups operated an effective system under article 56(5)(b) of the Standing Orders of the Conference for ensuring that deputy members of a committee voted in the place of regular members deprived of the right to vote, the same was not true of the Government group. As a result, if a Government that had lost the right to vote was appointed as a regular member of a committee, the distribution of votes between the three groups was distorted because the weighting of votes was based on the full regular membership and in practice the Government regular members of committees who were unable to vote did not make use of the possibility afforded by article 56(5)(a) of appointing a deputy member to vote in their place.

The Governing Body accordingly recommended that, in order to avoid such distortions, members of the Government group should not apply for regular membership of committees if they were not at the time in question entitled to vote. Should this practice, which had been maintained at all sessions of the Conference since 1987, for any reason not be fully respected, the weighting coefficients in committees should be calculated on the basis of the number of Government members entitled to vote.

*The Selection Committee accordingly confirmed that the calculation of weighting coefficients for votes in committees should be based on the number of regular Government members entitled to vote.*

## 9. Requests for representation in Conference committees submitted by international non-governmental organizations

In accordance with article 2(3)(j) of the Standing Orders of the Conference, the Governing Body had invited certain international non-governmental organizations to be represented at the present session of the Conference, it being understood that it would be for the Selection Committee of the Conference to consider their requests to be present at the committees dealing with items on the agenda in which they had expressed a particular interest.

The provision of the Standing Orders of the Conference which was relevant to such requests is article 56(9). In accordance with that provision, *the Selection Committee invited the following organizations to be represented in the committees stated:*

## **10. Appointment of the Conference Drafting Committee**

Due to time constraints related to the two-week format of this year's Conference, a proposal had been made to suspend articles 40(7) and 6(3) of the Standing Orders to the extent necessary to omit the review of the proposed Recommendation on Employment and Decent Work for Peace and Resilience by the Conference Drafting Committee, it being understood that the general responsibilities of the Conference Drafting Committee would be assumed by the Committee Drafting Committee. However, in the event that the Conference amended the text proposed by the Committee Drafting Committee, a short meeting of the Conference Drafting Committee might be necessary, and therefore, all members of the Conference Drafting Committee must be available on the day on which the report of the Committee on Employment and Decent Work for the Transition to Peace: Revision of the Employment (Transition from War to Peace) Recommendation, 1944 (No. 71), was submitted to the plenary of the Conference, that is Friday, 16 June.

*The Selection Committee decided that, in accordance with the provisions of article 6(1) of the Standing Orders and past practice, the Conference Drafting Committee should be composed as follows:*

- *the President of the Conference or his representative;*
- *the Legal Adviser;*
- *the Director of the International Labour Standards Department;*
- *the members of the relevant committee's drafting committee.*

## **11. Delegation of authority to the Officers of the Selection Committee**

In accordance with the usual practice and by virtue of article 4(2) of the Standing Orders, *the Selection Committee delegated to its Officers the authority to arrange the programme of the Conference and fix the time and agenda of plenary sittings as well as to decide on any non-controversial issues of a routine nature necessary for the running of the Conference.*

---

The effect of this delegation of authority was that the Selection Committee would only be called on to meet during the present session of the Conference if other substantive matters requiring a decision arose. Any such meeting would be announced in the *Daily Bulletin*.

## **12. Other questions: Electronic voting system**

A description of the electronic voting system, to be used in principle for all votes in plenary sittings in accordance with article 19(15) of the Standing Orders, as well as for the Governing Body elections if the electoral colleges so decided, is attached in Appendix II.

## Appendix II

### The electronic voting system

The electronic system provides for votes (in most cases: yes, no, abstention) to be expressed by means of a “voting station” that will be made available to all delegates or persons empowered to vote on their behalf.

This year, the Governing Body elections and the votes on the draft Recommendation submitted to the Conference by the Committee on Employment and Decent Work for the Transition to Peace are planned to take place using voting stations available for each delegation at their places inside the plenary hall. The votes on the draft Programme and Budget for 2018–19, on the abrogation of Conventions Nos 4, 15, 28, 41, 60 and 67, and any vote on the arrears of contributions of member States, are however planned to take place using voting stations available outside the plenary hall as well as outside the Governing Body room in the ILO. This is to allow the work of the plenary, committees or groups to continue during those particular votes.

Where the electronic system is used in the Assembly Hall, the subject and question to be voted on will be displayed and the President will announce the beginning of the vote. After the President has made sure that all delegates have been given sufficient opportunity to record their vote in one of the voting stations available to them, the President will announce the closure of the vote.

Where the method of vote is by show of hands, once all votes have been registered the final voting figures will be immediately displayed and subsequently published with the following indications: total number of votes in favour, total number of votes against, total number of abstentions and the quorum as well as the majority required.

Where a record vote is taken, once all votes have been registered, the final voting figures will be immediately displayed with the following indications: total number of votes in favour, total number of votes against, total number of abstentions and the quorum as well as the majority required. These indications will subsequently be published together with a list of the delegates who have voted, showing how each has voted.

In the case of a secret ballot, such as for Governing Body elections, once all votes have been registered, the final voting figures will be immediately displayed and subsequently published. There will be absolutely no access possible to individual votes, neither will there be any record of how each delegate has voted.

Should, for any reason, the system fail during a vote at the present session of the Conference, a back-up method of holding votes has been put in place.

It is important that each delegate should already have decided whether he or she or another member of their delegation will exercise the right to vote in a given case. Where more than one vote is nevertheless cast on behalf of a delegate at two different moments, or from two different places, only the first vote will be recognized, whether made by a delegate, by a substitute delegate or by an adviser who has received a specific written authorization to that end. Such specific authorizations must reach the secretariat sufficiently before the opening of voting is announced, so as to be duly recorded.

## Appendix III

### Proposal for the abrogation of four and withdrawal of two international labour Conventions

#### ***Abrogation of the Night Work (Women) Convention, 1919 (No. 4)***

The General Conference of the International Labour Organization,

Having been convened at Geneva by the Governing Body of the International Labour Office, and having met in its 106th Session on 5 June 2017, and

Following consideration of the proposal for the abrogation and withdrawal of several international labour Conventions under the seventh item on the agenda of the session,

decides this ... day of June of the year two thousand and seventeen to abrogate the Night Work (Women) Convention, 1919 (No. 4).

The Director-General of the International Labour Office shall notify all Members of the International Labour Organization, as well as the Secretary-General of the United Nations, of this decision to abrogate the instrument.

The English and French versions of the text of this decision are equally authoritative.

***Abrogation of the Minimum Age (Trimmers and Stokers) Convention, 1921 (No. 15)***
