Regulation 5 of the National Insurance (Contribution) Regulations, referred to in these Regulations as the principal Regulations, is amended –</p> <p>(a) in the head note by deleting the words “sixty” and inserting the words “pensionable age”; and</p> <p>(b) by deleting the words “the age of sixty” in each place where they occur and inserting the words “the pensionable age”.</p> | <p>Amendment of principal Regulations, Chapter 296</p> |
| <p>3. Regulation 18 of the principal Regulations is amended by deleting the words “the age of sixty” in each place where they occur and inserting the words “the pensionable age”.</p> | <p>Amendment of regulation 18</p> |
| <p>4. The Schedule of the principal Regulations is amended –</p> <p>(a) in Part I by–</p> <p>(i) deleting the words “sixty” and “the age of sixty” from the column headed “Description of employed person” and inserting in each case the words “the pensionable age”; and</p> | <p>Amendment of the Schedule</p> |

- (ii) deleting the figure "3 1/2" from the column headed "Rates of contribution" and inserting the figure "4 1/2"; and
- (b) in Part II by –
 - (i) deleting the words "sixty" and "the age of sixty" from the column headed "Description of employed person" and inserting in each case the words "the pensionable age"; and
 - (ii) deleting the figure "4 1/2" from the column headed "Rates of contribution" and inserting the figure "5 1/2".
