The following Acts and the regulations made thereunder apply to any person referred to in the Agreement on Social Security between the Gouvernement du Québec and the Government of the French Republic, signed at Paris on 17 December 2003, and appearing as Schedule 1 to the Regulation respecting the implementation of the provisions relative to industrial accidents and occupational diseases contained in the Agreement on Social Security between the Gouvernement du Québec and the Government of the French Republic (chapter S-2.1, r. 22):

- (1) the Hospital Insurance Act (chapter A-28);
- (2) the Health Insurance Act (chapter A-29);
- (3) the Act respecting prescription drug insurance (chapter A-29.01);
- (4) the Act respecting the Régie de l'assurance maladie du Québec (chapter R-5);
- (5) the Act respecting the Québec Pension Plan (chapter R-9);
- (6) the Act respecting health services and social services (chapter S-4.2); and
- (7) the Act respecting health services and social services for Cree Native persons (chapter S-5).

2. Those Acts and regulations apply in the manner set out in the Agreement and in the administrative arrangement for its implementation, which appears as Schedule 2 to the Regulation referred to in section 1.
