# Developing a Series of Policy Briefs to inform the development of a Social Economy Policy in South Africa

#### 1. Background

The Social Economy in South Africa is an area of growing interest, which brings the best of civil society together with the best of business. The result is organisations that deliver social value in a sustainable way – our co-operatives, social enterprises, and non-profits who trade.

The Government of South Africa is committed to growing the potential of the social economy in South Africa, with commitments in both the New Growth Path and the National Development Plan. For example, the New Growth Path (NGP) adopted in late 2010 by the South African Government identifies social economy development as one pillar of the national development strategy framework. And the Decent Work Country Programme (DWCP) drawn up by organized business, organized labour, Community and Government in consultation with ILO and governed by the National Economic Development and Labour Administration Council (Nedlac) identifies the development of the social economy as a strategic means leading towards the creation of jobs in sustainable enterprises.

The Department of Economic Development together with the ILO is working to deliver a policy that will enable the ecosystem for the social economy, allowing it to thrive. This three year project works across three pillars:

The following topics have been identified for the policy brief series. Please note that the final five policy briefs will be agreed together with the commissioned consultant.

- Definition of the Social Economy in SA, with the goal of creating a working definition for the policy process.
- 2. Opportunities and threats for the growth of the social economy in South Africa. What needs to be done to realise the potential of the social economy in SA?
- 3. Supporting the growth of the social economy in South Africa: points of strength and points of weakness



#### Policy Brief Series 2: Social economy organisations in South Africa

Possible topics could include:

- Understanding the regulatory environment in South Africa: the organisations that make up the social economy.
- Supporting the growth of social economy organisations in South Africa: points of strength and points of weakness
- 6. Managing tensions between profit and purpose: dilemmas and difficulties of South Africa's social economy organisations.

Possible topics could include:

- 7. Connecting impact and income: the social economy and systemic change

Possible topics could include:

- 13. Models for innovative finance in South Africa
- 14. Funding and financing of the social economy looking back, looking forward. What's worked and what hasn't.

# 3. Tasks of the collaborator / consultant

The Consultant, or consulting company, will perform the following tasks in the process of developing the policy brief:

- a) Review available study reports done by the ILO and other relevant documents.
   It must be understood that the field is nascent in South Africa and we are building knowledge specific to the South African context.
- b) Literature review on the social economy including relevant ILO Recommendations and documents<sup>1</sup>;
- c) Desk review of statistical data and information on initiatives related to enabling the ecosystem for the social economy
- d) Seek feedback from ILO , its tri-partite constituents and other stakeholders (as advised by the ILO);
- e) Seek review comments to the draft policy brief from national experts (as advised by the ILO);
- f) Incorporate review comments and suggestions;
- g) Present draft policy briefs for input and comments
- h) Submit the final policy brief series

This work is commissioned as a series of five policy briefs. Collaborations are encouraged to ensure expertise is applied to different subject areas. Each policy brief should be:

- At least 2000 words (approx. five pages), with referencing as Endnotes. One page at the end will be reserved for a list of documents /reports reviewed and a brief introduction of the Social Economy Policy Project, and other general information.
- General headings that can be applied:
  - Executive Summary
  - o Description of the policy challenges
    - Statistics / quantitative data that supports this description
  - o Policy options to address the challenges
  - Examples that illustrate the issue. Examples that illustrate the solution.
  - o Identified bottlenecks that hinder the development and growth of the sector
  - o Conclusions and recommendations
  - "Key facts" fact box
  - o Recommended reading
  - o Sources

Guidelines that can be applied to the Policy Brief Series:

- Conclusion should include numbered recommendations to the South African government on how to best support the development and growth of the social economy.
- Figures and diagrams are recommended
- Photographs and quotes in high resolution
- Contributors (individuals and institutions) should be acknowledged
  - The appointed consultant/s will be requested to participate at a National Consultation, dates to be confirmed.



# 5. Required skills, competencies and experience

The Consultant/s is required to have:

- Sound technical background and experience in the social economy in South Africa;
- Sound experience and knowledge on the work done by the ILO on the social economy in South Africa
- · Excellent written English and interviewing skills and techniques.
- A track record of professional experience working in the social economy or with social economy organisations; especially in the production of written reports and research.
- · Ability to deliver content for high-impact reports
- Experience of developing policy briefs will be advantageous;
- Understanding of the South African government's policies on Small Business Development,
   Economic Development and related policies and regulations is an advantage.
- Understanding of on-going debates/discussion and on the challenges facing the social economy
  is an advantage.

#### 6. Budget

# Terms of Reference Developing a series of Thematic Papers to inform the development of a Social Economy Policy in South Africa

# 1. Background

They are more detailed than policy briefs and should be regarded as accessible, readable pieces of research.

# 2. Purpose of the Assignment

The purpose of this assignment is to commission a number (minimum three) Thematic Papers that provide substantive insight into areas of the social economy in South Africa. Because this is a nascent field, substantial desktop research will be required with possible focus groups / action research approaches. The following topics have been suggested for individual thematic papers by the organising team:

- 1. Synthesis report: background to and scoping of, the Social Economy in South Africa (including definitional discussion).
- 2. Analysis: International Lessons what can we learn about the growth of the social economy from countries other than our own.
- 3. Current regulatory and public policy environment: A map of existing policies that enable the social economy in South Africa, identifying where the policy gaps are.
- 4. Challenges and opportunities to developing the Social Economy in South Africa a. Recommendations and approaches.
- Funding and financing of the social economy in South Africa: mapping of the financing eco-system in South Africa, identifying areas of strength and weaknesses and

The Policy team encourage recommendations from applicants on possible research areas.



#### 3. Tasks of the collaborator

The Consultant will perform the following tasks in the process of developing the thematic papers:

- a) Review available study reports done by the ILO and other relevant documents that inform and influence the development of the social economy in South Africa (e.g.: The New Growth Path, The National Development Plan, The Co-operatives Act etc.).

  It must be understood that the field is nascent in South Africa and we are building knowledge specific to the South African context. It will be important to write what it is we know, and at the same time, what we don't.
- b) Desk review of statistical data and information on initiatives related to enabling the eco-system for the social economy
- c) Seek review comments to the thematic paper through a reference panel to be identified by the ILO;
- d) Incorporate all review comments and suggestions (a maximum of three rounds of reviews is recommended);
- e) Submit the thematic paper to the ILO

The ILO will cover the costs of proof reading, design and printing separately.

# 4. Structure of the Thematic Paper

The Thematic Paper should be:

- At least 6,000 words (no less than 10 pages, up to 20 pages) (one page at the end will be reserved for a list of documents / reports reviewed and a brief introduction of the Social Economy Policy Project, and other general information).
- Include case studies as examples from the research process.
- The Thematic Papers will feed into the Discussion Document going into the policy process, and ultimately the foundation of the Green Paper.

- · Ability to synthesise information from a wide range of sources.
- Ability to present complex information in a manner that is accessible to a broad range of stakeholders.
- · Experience of working in the policy environment will be advantageous;
- Understanding of the South African government's policies on Small Business Development, Economic Development and related policies and regulations;
- Understanding of on-going debates/discussion and challenges facing the Social Economy in South Africa
