Annex I: Call for Expression of Interest

TERMS OF REFERENCE

Call is open to all eligible National Civil Society Organizations and specialized companies wishing to partner with ILO on "consultancy for data entry for the department of Social Security in Iraq" Starting in August 2022 for a period of 6 months *Deadline for submission of proposals: July 12th*, 2022

I. Introduction:

The contributory social insurance system in Federal Iraq is composed of two funds: the state pension system (covering, inter alia, civil servants and employees in state- owned enterprises) provides for pensions in case of old-age, disability and death. Workers in the private sector are covered by the Social Security Law No. 39 of 1971and its amendments. Although the law provides for several social security benefits, including for sickness and maternity, only the pensions system is currently accessible to private sector workers. Nevertheless, workers in the informal economy, which accounts for a considerable share of private sector employment, are currently not covered by any form of social insurance.

The Department of Social Security at the Ministry of Labor and Social Affairs identified gaps in knowledge about the exact coverage of the Social Security System for private-sector workers, which is related in particular to the slow pace of entering the data of registered workers into the database, and therefore keep that database up-to-date.

The ILO is looking to support the DSS to update their database of registered or applicant workers – as well as of registered workers in receipt of social security benefits – by entering the backlog of paper-based files into the database.

II. OBJECTIVE AND SCOPE OF WORK

Under the direct supervision of the DSS' assigned manager, the consultancy will **deploy 15 data entry clerks to work 6 months on a full-time basis (7 hours a day)** to enter the data of registered or applicant workers into the DSS database. The clerks are expected to have laptop computers of sufficient capacity. All equipment purchased for this assignment including laptops must be delivered to the DSS. The selected implemented partner will adhere to the data security instructions provided by the DSS. It is the responsibility of the selected implementing partner to adhere to Iraq's decent work conditions provided by the Labor Law and the Social Security Law.

The key works of the partner to deliver

- Initial report on the total number of files to be entered into the database (i.e. size of the backlog)
- Monthly report of data entered (including as expressed as a percentage of all data to be entered)
- Attendance sheets of each of the 15 data entry clerks verified by the DSS' assigned manager.
- Laptops used are handed over to DSS, verified by the DSS' assigned manager



IV. DURATION OF THE ASSIGNMENT

The partner will deliver the project output as per the proposal and work plan and will be delivering the activities for six months.
