PROJECT OBJECTIVES

This project is implemented by four UN Agencies in China, including ILO, UNESCO, UNDP and UNICEF.


The four Agencies work together for the objective of mainstreaming of rights and entitlements of persons with disabilities into the policies and activities of key government agencies, including their rights to education, employment, as well as the principles of justice and social participation advanced.

Based on ILO's mandate, more specific objective for ILO is to create better work and employment opportunities for men and women with disabilities, through the creation of an enabling legal and policy environment, the promotion of skills development opportunities and measures to eliminate discrimination.

The project is implemented with a gender—sensitive and a gender-responsive approach.

MAIN ACTIVITIES

- Social dialogue conferences on inclusive education and training in pilot provinces of CDPF, DPOs and employers' and workers' organizations on the employment of people with disabilities and the rights to quality education and training for children with disabilities.
- Seven Disability Equality Training (DET) and one training of facilitator of DET workshop for CDPF, governmental counterparts and DPOs.
- Workshops on leadership and advocacy capacity building for DPOs on promoting rights and employability of persons with disabilities, especially persons with intellectual disabilities and women with disabilities.
- Training media professionals on portray disability issues as issues of human rights.
- Support to companies, trade unions and employers' organizations to share experiences on hiring and training men and women with disabilities.

PROJECT OUTCOMES

- Strengthened institutional capacity of CDPF and DPOs to advocate for the rights of persons with disabilities and improve their partnership with national and local authorities.
- Strengthened capacity among civil servants, and key professional categories to protect and fulfil the rights, entitlements and legal protections afforded to persons with disabilities (In collaboration with other UN Agencies, ILO is responsible for media professional companies, professionals from trade unions and employers' organizations).
