Mr Khalid Hassan is the Director of the International Labour Organization (ILO) Country Office for the Philippines. He is responsible for leading ILO programmes and initiatives in the Philippines, and supporting the country to achieve sustainable and inclusive growth through the Decent Work Country Programme (DWCP). The DCWP reflects the commitment of the government, workers and employers organizations to promote decent work as a key element of economic, social and environmental policies and national development strategies. Mr Hassan has an extensive background on fundamental principles and rights at work, rural development and primary education. Prior to his assignment in the Philippines, he has served for 17 years in the ILO Country Offices for Zambia, Malawi and Mozambique and in Tanzania and Pakistan.

Ms Linda Deelen is the Manager of the Enterprise, Microfinance and Local Development Programme (EMLD) at the International Training Centre of the ILO, with portfolio of training and capacity building on SME development, financial services, rural and local development, cooperatives and the social and solidarity economy. Before joining the Centre, she worked as ILO Enterprise Specialist in Geneva and in different field offices in Asia and Latin America. For over 20 years, she provided technical support, training and advisory services to public and private institutions on private sector development with a particular focus on small- and medium-sized enterprises. Ms Deelen is the author and co-author of publications on women entrepreneurship, enterprise formalization and SME finance.
