Silas Santiago, Executive Secretary of Management Committee of the Micro and Small Enterprises Special Tax Regime (CGSN), Government of the Brazil

Mr Silas Santiago is the Executive Secretary of Management Committee of the Micro and Small Enterprises Tax Special Regime (CGSN) linked to the Ministry of Finance of the Brazil. Since 2007, he headed the implementation of Simples Nacional, which unifies the collection, recovery and control of federal, state and local taxes and contributions.

From 2009 onwards, he also manages the Individual Microentrepreneur (MEI) programme, one of the major programmes of informality business reduction worldwide. He obtained his Master of Tax Administration and Tax Policy, from the Institute of Fiscal Studies, in Madrid, Spain in 2015.











### Lysette Henríquez Amestoy, Chilean, Industrial Civil Engineer, University of Chile (Universidad de Chile)

Ms Lysette Henríquez Amestoy is Chair of the Board of Correos de Chile. She headed a Master's Programme and served as Director for Innovation and Transfer of Technology at the University of Chile. In Mexico, she worked as General Director of Fundes and as Programme Coordinator of UNDP. In Chile, she served as General Manager of SERCOTEC on SMEs; National Director of JUNAEB (National Board of School Assistance and Scholarships) and advisor to the Minister of Labour; Vice-president of INTEC (Institute of Technological Research), Counsellor of the National Center for Productivity and Quality and INACAP (National Institute of Professional Training). She was appointed also as technical secretary of the Latin American Organization of SMEs (OLAMP). She worked as Consultant for international organizations in Latin America, Africa and Europe such as: ECLAC, UNDP, ILO, PREALC, UNIDO, ILPES, UNFPA; as well as the IDB, AID and governments and private companies. She participated in postgraduate studies at the Instituto Tecnologico de Monterrey in Mexico. She has developed training activities as rapporteur, facilitator and organizer in various Latin America. She published books and papers on productive development and competitiveness. She has been a member of the jury of the SME Competitive Management award in Chile Calidad and has also been national advisor to the College of Engineers of Chile.



#### Juan Pablo Martínez, Economist, Uruguay



He was also the Director General (2009-14) of the National Institute of Labour Economics Research, Planning Commission.
