The Common Agenda on Migration and Mobility (Camm) offers a comprehensive framework for cooperation between the European Union and their priority partner countries. India and the European Union signed the Camm in 2016 and, in view of their strengthening strategic partnership, the **EU-India Cooperation and Dialogue on Migration and Mobility project** will support the promotion of better mobility and migration governance between the EU and India.

This project aims specifically at:

Strengthened regular, structured and reliable dialogue on issues related to migration and mobility between India and the EU

Enhanced legal, policy and administrative institutional capacity of India and the EU on migration management

Improved knowledge base of migration flows between India and the EU

Increased awareness and tools to adopt international standards and best practices on migration management
