#### WHAT DOES PARTNERSHIP INVOLVE?

There are many ways to contribute to the network and its aims. Options for involvement include, but are not restricted to, those below.

- Join expert working groups, which find solutions to, and take action on, specific issues.
- Share good practice, lessons learned or tools and resources, for instance by co-hosting or participating in a webinar or a country-level technical workshop.

#### WHAT IS THE APPLICATION PROCESS?

Business-led initiatives with a similar or complementary mandate may join ILO GBNFL free of charge in exchange for in-kind support. Following initial discussions with the ILO GBNFL Secretariat, potential partners send a formal expression of interest, signed by the head of the organization, committing to the agreed-on support.

Once the Steering Committee has approved the application, new partners may be asked to sign a partnership agreement with the ILO and ILO GBNFL. Partnerships are evaluated annually.
