### SRM TWG working paper 2: Background material for defining the SRM TWG's programme of work

To facilitate the Standards Review Mechanism Tripartite Working Group (SRM TWG) in defining its programme of work, this working paper presents two elements that inform the consideration by the SRM TWG of its programme of work. This material is intended to supplement the mapping exercise undertaken in the first working paper on these procedural elements.

#### Terminology to describe the status of instruments

The SRM TWG shall, as set out in its terms of reference, review the international labour standards with a view to making recommendations to the Governing Body on "the status of the standards examined, including up-to-date standards, standards in need of revision, outdated standards, and possible other classifications".\*

In the first section, this working paper will explain the various terms that have, to date, been used to describe the status of international labour standards. This aims to assist the SRM TWG when it comes time for it to decide the terminology it will use to express the output of its reviews on the status of instruments, ensuring transparency and clarity.

#### Grouping of instruments by strategic objective for the purposes of review

The SRM TWG's terms of reference require its reviews to be organized according to the four ILO strategic objectives. † The SRM TWG review should take a holistic and thematic approach to the instruments based on the strategic objectives.

The second section of the paper sets out a grouping of the body of standards by strategic objective. This is intended to facilitate the work of the SRM TWG in deciding how to articulate its programme of work to both build upon and feed into other ILO initiatives including, most particularly, the recurrent discussions. The section will highlight the wider context of the sets of standards that fall within the focus of the SRM TWG's initial review.

# I. Terminology to describe the status of standards

The SRM TWG will decide, in due course, how it will describe the status of instruments that it has reviewed. The output of the SRM TWG's reviews will be a

recommendation as to the status of standards as up to date, in need of revision or outdated, with the possibility that the SRM TWG may choose to use other classifications of status.\*

Currently, each international labour standard has a status ascribed by the Governing Body, often based on recommendations by the Cartier Working Party. In some cases, the classification of status involves terminology developed by the Office. The terminology used to describe the status of standards can be understood as dividing into three broad groups.

The following explanation of the different classifications of status that have been used in relation to the body of international labour standards may be helpful background information for the SRM TWG as it develops its work methods and procedures.

#### The body of international labour standards

Up-to-date instruments	Other; interim; information requested; no conclusions	To be revised	Outdated instruments	

### Instruments that are "up to date and relevant to the world of work"

Certain instruments are considered to be – in the words of the SRM TWG's terms of reference – "up to date and relevant to the world of work".

Up-to-date instruments are those that are fit for purpose. The SRM TWG's terms of reference refer to a body of instruments that is clear, robust and up to date and is able to respond to the changing patterns of the world of work, for the purpose of the protection of workers and taking into account the needs of sustainable enterprises. The Office should promote the ratification and implementation of up-to-date international labour standards.

Up-to-date instruments include all standards that the Governing Body classified as continuing to respond to current needs following the recommendations of the Cartier Working Party. Further, recently adopted instruments (understood for the purposes of the SRM TWG as instruments that have been adopted after 2000) are deemed to be up to date.

### Instruments that have not been classified as up to date or outdated

A further group of classifications of status for standards partially overlap in some cases.

#### Requests for information

On the recommendation of the Cartier Working Party, the Governing Body decided that further information was necessary in relation to certain instruments. In some cases, this involved carrying out a General Survey or a short survey.\* In other cases member States were requested to provide additional information on an ad hoc basis in relation to obstacles to ratification or implementation, or on any possible need to revise or replace an instrument †

### Interim instruments, other instruments or instruments for which the status quo is maintained

In follow-up to the Cartier Working Party, the Governing Body decided to "maintain the status quo, considering that no other type of decision was appropriate" in relation to certain instruments. According to the 2002 Office document summarizing the follow-up to the recommendations of the Cartier Working Party, the category of "other instruments" comprises instruments which are no longer fully up to date but remain relevant in certain respects. These instruments have subsequently been re-designated as "instruments with interim status".

#### Instruments to be revised

On the basis of recommendations by the Cartier Working Party, the Governing Body identified a number of Conventions and Recommendations for revision. Revision of an instrument may involve the adoption of a Protocol to a Convention, or a new Convention or Recommendation fully or partially replacing an instrument.

#### **Outdated instruments**

Outdated instruments are at the other end of the spectrum from up-to-date instruments. These instruments are considered to be no longer fit for purpose because they no longer reflect the reality of the world of work.

As was set out in the Office document summarizing the follow-up to the recommendations of the Cartier Working Party, this category:\*\*

includes Conventions that have been shelved and those Conventions which the Governing Body has invited States parties to denounce while inviting them at the same time to ratify more recent Conventions on the same subject matter. This category also includes Recommendations that have been juridically replaced by subsequent instruments or declared obsolete by the Governing Body.

#### Shelved instruments

In follow-up to the recommendations of the Cartier Working Party, the Governing Body shelved Conventions "which no longer corresponded to current needs and had

become obsolete".\* Shelved instruments are no longer promoted or discussed in Office documents and are effectively closed to new ratifications. While they are not the subject of requests for regular reports, they may be the subject of the procedures under articles 24 and 26 of the ILO Constitution and observations under article 23. Shelved instruments will also retain their legal status in the legal systems of ratifying States.†

#### Abrogated instruments

Following the entry into force of the 1997 Instrument for the Amendment of the Constitution, the possibility exists to abrogate obsolete Conventions which are still in force. Abrogation has the effect of eliminating definitively all legal effects arising out of an obsolete Convention in force between the Organization and its Members parties to that Convention. Abrogated Conventions will be removed from the ILO's body of standards.<sup>‡</sup>

At its November 2015 session, the Governing Body placed an item on the abrogation of Conventions Nos 4, 15, 28, 41, 60 and 67 on the agenda of the 106th Session (June 2017) of the Conference.

#### Withdrawn instruments

While abrogation only relates to Conventions in force, Conventions that are not in force as well as Recommendations may be withdrawn by the Conference. Five Conventions and 36 Recommendations have been withdrawn so far.§ The withdrawal of instruments will put an end to their legal effects vis-à-vis the Organization and contribute to the rationalization of the body of international labour standards.\*\*

# II. Grouping of international labour standards by strategic objective

A necessary starting point for the implementation of the SRM TWG's programme of work is the grouping of all international labour standards by strategic objective. This will enable it to organise its review according to those strategic objectives, in accordance with the SRM TWG's terms of reference. ††

The following list of standards by strategic objective is an updated version of the list that was presented to the Governing Body in March 2011, <sup>‡‡</sup> to include instruments adopted since 2011.
