إنشاء لجنة استشارية مستقلة للإشراف

اضافة

- ١. منذ نشر الوثيقة GB.300/PFA/5 التي تطلع اللجنة على آخر ما استجد بشأن وضع المشاورات المتعلقة بإنشاء لجنة استشارية مستقلة للإشراف، أجري المزيد من المشاورات في هذا السياق. وفي حين ما زال هناك من يعبر عن بعض التحفظات، لا سيما بشأن القيمة المضافة لمثل هذه اللجنة، ظهر اتفاق واسع النطاق بشأن إنشاء لجنة استشارية مستقلة للإشراف على أساس تجريبي.
- ٢. وتجيب الاختصاصات المنقحة الملحقة بهذه الوثيقة على التعليقات الواردة من الأعضاء منذ الدورة الأخيرة لمجلس الإدارة. وهي توضح بالأخص أن إنشاء لجنة استشارية مستقلة للإشراف لا يُبطل بأي حال من الأحوال وظيفة الإشراف التي تضطلع بها لجنة البرنامج والميزانية والإدارة والوظائف الأخرى المحددة في النظام الداخلي لمجلس الإدارة أ. وتعرّف الاختصاصات ولاية اللجنة الاستشارية المستقلة للإشراف ودورها وتوضح أن هذه اللجنة ستسدي المشورة وتقدم التوصيات إلى اللجنة وأنها لن تمارس أية سلطة اتخاذ قرار. كما توضح الاختصاصات بقدر أكبر المسؤولية المتعلقة باقتراح الأعضاء وتعيينهم ومعايير الاستقلالية.
- ٣. ويُقترح إنشاء اللجنة الاستشارية المستقلة للإشراف على أساس تجريبي لفترة أربع سنوات. وخلال السنة الثالثة سيُجرى استعراض ويُقدم تقرير إلى مجلس الإدارة. وسيشمل التقرير تقييما للقيمة المضافة التي تعود بها هذه اللجنة على إدارة المنظمة.
 - ٤. قد ترغب اللجنة بالتالي في توصية مجلس الإدارة بما يلي:
- "أ" الموافقة على إنشاء لجنة استشارية مستقلة للإشراف على أساس تجريبي لفترة أربع سنوات وفقا للاختصاصات الملحقة بهذه الوثيقة؛
- "ب" الطلب إلى المدير العام أن يوعز باجراء استعراض بشأن اللجنة الاستشارية المستقلة للإشراف خلال السنة الثالثة من عملها وأن يرفع تقريرا بشأن ذلك إلى مجلس الإدارة ؛
- "ج" الطلب إلى المدير العام أن يقترح مرشحين لعضوية اللجنة الاستشارية المستقلة للإشراف لتنظر لجنة البرنامج والميزانية والإدارة في ترشيحهم بعد إجراء مشاورات مع هيئة مكتب مجلس الإدارة.

Appendix

Independent Oversight Advisory Committee

Terms of reference

Under the Standing Orders of the Governing Body, the Programme, Financial and Administrative Committee of the Governing Body shall study any financial and administrative questions referred to it by the Governing Body or submitted to it by the Director-General. Without prejudice to the role of the Programme, Financial and Administrative Committee as defined under the Standing Orders of the Governing Body, the Independent Oversight Advisory Committee of the International Labour Office, reporting to the Programme, Financial and Administrative Committee, assists the Governing Body in fulfilling governance and oversight responsibilities. Its primary functions are:

- (1) to review the operation and effectiveness of the Financial Regulations and Financial Rules;
- (2) to review management's risk assessment and to ensure that the risk management process is comprehensive and ongoing;
- (3) to confirm audit arrangements have been conducted and delivered during the year to provide the necessary levels of assurance required by the Director-General and the Governing Body;
- (4) to monitor the timely, effective and appropriate responses to internal and external audit recommendations;
- (5) to provide upon request, advice to the Director-General on issues within the mandate of the Committee;
- (6) to prepare an annual report, which shall be presented by the Chairperson to the March session of the Programme, Financial and Administrative Committee. The Committee may also report key findings and matters of importance to the Programme, Financial and Administrative Committee at any other session.

Composition

The Committee shall comprise five members who have demonstrated integrity, objectivity and expertise in senior positions in the areas covered by these terms of reference.

Members of the Committee shall be appointed by the Governing Body on the recommendation of the Programme, Financial and Administrative Committee. The Director-General shall propose candidates to the Programme, Financial and Administrative Committee following consultations with the Officers of the Governing Body.

Members will provide services pro bono.

Independence is a fundamental requirement of members. Members serve in their personal capacity and shall not seek or accept instructions in regard to their performance on the Committee from any government, constituent organization or other authority external or internal to the International Labour Office. They shall be independent of the United Nations Panel of External Auditors, the Joint Inspection Unit, the Governing Body of the International Labour Organization and the International Labour Office and shall not

hold any position or engage in any activity that could impair their independence from the Office or from companies that maintain a business relationship with the Office. All members will be required to sign a declaration of independence.²

- Members should possess relevant professional financial qualifications and recent experience in accounting, auditing, risk management and other financial and administrative matters.
- Members should have or acquire rapidly an understanding of the objectives of the Organization, its tripartite governance and accountability structure and the relevant rules governing it; its organizational culture and control environment.
- Committee membership should include a balance of representation with public and private sector experience.
- At least one member shall be selected based on his/her qualifications and experience as a senior oversight professional or senior financial manager in the United Nations system or another international organization.

Expertise should guide the selection process with due regard given to the tripartite nature of the Organization, geographical distribution and gender.

The Chairperson of the Committee shall be selected by the members of the Committee.

The Director-General, External Auditor, Treasurer and Financial Comptroller, Chief Internal Auditor or their representatives shall attend meetings when invited by the Committee. Other officials with functions relevant to the items on the agenda may likewise be invited.

Term of office

The term of office shall be four years. The initial appointment of two of the members shall be for a period of two years to ensure continuity of membership.

The Chairperson of the Committee shall serve in this capacity for a term of two years.

Appointment to the Committee may only be revoked by the Governing Body on the recommendation of the Programme, Financial and Administrative Committee.

Administrative arrangements

Members of the Committee not resident in the Canton of Geneva or neighbouring France shall be entitled to the reimbursement of travel expenses in accordance with Office procedures applying to senior officials.

The Committee shall meet twice per year – normally in February and September. Exceptionally, the Committee may convene an extraordinary meeting when required.

The quorum for meetings of the Committee shall be three members.

The Committee shall adopt its own rules of procedure which shall be communicated to the Programme, Financial and Administrative Committee. The Committee may propose amendments to its terms of reference for consideration by the Governing Body.

The Office will provide support to facilitate the work of the Committee.
