Sectoral meetings held in 2018 and proposals for sectoral work in 2019

Purpose of the document

The Governing Body is invited to take note of the reports of two meetings held in the first half of 2018 (see section I), to authorize respective follow-up, including the publication of the *Code of practice on safety and health in shipbuilding and ship repair* and the *Guidelines on decent work in public emergency services*, and to endorse the proposals made in section II in relation to upcoming sectoral meetings (see the draft decision in paragraph 10).

Relevant strategic objective: Social dialogue and tripartism.

Main relevant outcome/cross-cutting policy driver: Cross-cutting policy driver: social dialogue.

Policy implications: The code of practice and the guidelines would become ILO guidance on the matter.

I. Meetings held in the first half of 2018

A. Meeting of Experts to Adopt a Code of Practice on Safety and Health in Shipbuilding and Ship Repair (Geneva, 22–26 January 2018)

1. In accordance with an earlier decision of the Governing Body,¹ the Meeting was held in Geneva from 22 to 26 January 2018.
2. The Meeting was chaired by Mr César Augusto Gomez Ruiloba (Panama). The five Vice-Chairpersons were: Ms Wenhui Fei (China) and Ms Teniola Oluwayemisi Fayemi (Nigeria) from the Government group; Mr John Beckett and Mr Wirrick Williams from the Employers' group;² and Ms Deborah Vallance from the Workers' group.
3. The Meeting was attended by 22 experts – eight experts from governments, eight experts nominated by the Employers' group and six experts nominated by the Workers' group of the Governing Body. The Meeting was also attended by 22 Government observers and three Workers' advisers. There were seven observers from international non-governmental organizations.
4. The purpose of the Meeting was to review and adopt a revised Code of practice on safety and health in shipbuilding and ship repair, to replace the code adopted in 1973 on the same subject. A draft had been prepared by the Office and served as the basis for the discussions. The report summarizes the Meeting's discussions,³ which were concluded with the adoption of the revised code of practice.⁴

B. Meeting of Experts to Adopt Guidelines on Decent Work in Public Emergency Services (Geneva, 16–20 April 2018)

5. In accordance with an earlier decision of the Governing Body,⁵ the Meeting was held in Geneva from 16 to 20 April 2018.
6. The Meeting was chaired by Mr Deepak Dhital (Nepal). The three Vice-Chairpersons were: Ms Teresa Cucueco (Philippines) from the Government group; Mr Paul MacKay from the Employers' group; and Mr David Boys from the Workers' group.
7. The Meeting was attended by 24 experts – eight from governments, eight nominated by the Employers' group and eight nominated by the Workers' group of the Governing Body. In

addition, observers from 33 governments attended the Meeting. There were also eight observers from intergovernmental organizations and international non-governmental organizations.

8. The purpose of the Meeting was to review and adopt Guidelines on decent work in public emergency services. A draft had been prepared by the Office and served as the basis for the discussions. The report summarizes the Meeting's discussions,⁶ which were concluded with the adoption of the Guidelines.⁷

II. Upcoming meetings

A. Meetings to be held in the second, third and fourth quarters of 2019

9. In light of the adoption of the programme of sectoral meetings for 2018–19 by the Governing Body at its 329th Session (March 2017),⁸ the Office has prepared the attached list with proposals regarding dates, duration, official title, purpose and composition of the remaining meetings envisaged for 2019. The list complements the decisions of the Governing Body at its March 2018 session regarding sectoral meetings to be held in the second half of 2018 and the first quarter of 2019.⁹

Draft decision

10. *The Governing Body:*

- (a) *took note of the reports of the meetings referred to in section I;*
- (b) *authorized the Director-General to publish the Code of practice on safety and health in shipbuilding and ship repair (revised edition) and the Guidelines on decent work in public emergency services;*
- (c) *requested the Director-General to bear in mind, when drawing up proposals for future work, the recommendations for future action by the ILO made by the meetings referred to in section I;*
- (d) *endorsed the proposals contained in the appended table relating to the dates, duration, official title, purpose and composition of the meetings listed therein.*
